INTRODUCTION

The *Hairdressing* program was designed on the basis of a framework for developing vocational education programs that calls for the participation of experts from the workplace and the field of education.

The program of study is developed in terms of competencies, expressed as objectives. These objectives are divided into modules. Various factors were kept in mind in developing the program: training needs, the job situation, purposes, goals, and strategies and means used to attain objectives.

The program of study lists the competencies that are the minimum requirements for a **Diploma of Vocational Studies (DVS)**, for students in both the youth and adult sectors. It also provides the basis for organizing courses, planning teaching strategies, and designing instructional and evaluation materials.

The *Hairdressing* program leads to the Diploma of Vocational Studies. To be admitted to the program, students must meet one of the following conditions:

 For students holding a Secondary School Diploma or a recognized equivalent, no additional conditions are required.

OR

- For students who are at least 16 years of age on September 30 of the school year in which they begin
 the program, the following condition applies: they must have obtained Secondary IV credits in
 language of instruction, second language and mathematics, or the recognized equivalents.
 OR
- For students who are at least 18 years of age, successful completion of the General Development Test and the SPR01 test in the language of instruction, or its equivalent, are prescribed as functional prerequisites.

OR

 For students who have obtained Secondary III credits in language of instruction, second language and mathematics in programs established by the Minister, general education is required in conjunction with vocational education in order to obtain the following credits, if applicable: Secondary IV language of instruction, second language and mathematics in programs established by the Minister.

The duration of the program is 1455 hours, which includes 1260 hours spent on the specific competencies required to practise the trade and 195 hours on general competencies. The program of study is divided into 21 modules which vary in length from 15 to 120 hours (multiples of 15). The time allocated to the program is to be used not only for teaching but also for evaluation and remedial work.

The document contains two parts. Part I is of general interest and provides an overview of the training plan. It includes a synoptic table of the basic information about the modules, a description of the program training goals, the competencies to be developed and the general objectives, and an explanation of operational objectives. Part II is designed primarily for those directly involved in implementing the program. It contains a description of the operational objectives of each module.

GLOSSARY

Program Training Goals

Statements that describe the educational aims of a program. These goals are the general goals of vocational education adapted to a specific trade or occupation.

Competency

A set of knowledge, skills, perceptions and attitudes that enable a person to correctly perform a work-related activity or task.

General Objectives

Expression of the educational aims of a program in terms of competencies to be developed. The general objectives are broken down into operational objectives.

Operational Objectives


Statements of the educational aims of a program in practical terms. They serve as the basis for teaching, learning and evaluation. In the competency-based approach, the educational aims are expressed as competencies to be developed.

Module of a Program

A component part of a program of study comprising an operational objective.

Credit

A unit used for expressing quantitatively the value of the modules in a program of study. One credit corresponds to 15 hours of training. Students must accumulate a set number of credits to graduate from a program.

2 PROGRAM TRAINING GOALS

The training goals of the *Hairdressing* program are based on the general goals of vocational education and take into account the specific nature of the trade. These goals are:

To develop effectiveness in the practice of a trade

- To teach students to perform hairdressing tasks and activities correctly and at an acceptable level of competence for entry into the job market.
- To permit students to develop adequately in the trade by fostering:
 - a concern for communicating professionally with superiors, colleagues and clients
 - a constant concern for occupational health and safety
 - the development of attentiveness and precision in carrying out work-related tasks
 - the development of clean, orderly work habits

To ensure integration into the working world

- To familiarize students with the job market in beauty care in general and the hairdressing trade in particular.
- To familiarize students with workers' rights and responsibilities.
- To prepare students for a creative job search.

To foster the development of occupational knowledge

- To foster the acquisition of the intellectual skills required to make the appropriate choices and decisions when performing work-related activities.
- To foster autonomy, a sense of responsibility, initiative, creativity and good judgment.
- To foster the acquisition of appropriate, safe and effective work methods.
- To foster an understanding of the principles underlying the choice of products and techniques.

To ensure job mobility

- To help students acquire a solid basic education as well as the knowledge and skills that ensure job mobility.
- To help students develop a positive attitude toward change and new situations.
- To encourage further learning, creativity and excellence.

3 COMPETENCIES

The competencies to be developed in the *Hairdressing* program are shown in the grid of learning focuses on the following page. The grid lists general and specific competencies as well as the major steps in the work process.

General competencies involve activities common to several tasks or situations. They cover, for example, the technological or scientific principles that the students must understand to practise the trade. Specific competencies focus on tasks and activities that are of direct use in the trade. The work process includes the most important steps in carrying out the tasks and activities of the trade.

The grid of learning focuses shows the relationship between the general competencies on the vertical axis and the specific competencies on the horizontal axis. The symbol (Δ) indicates a correlation between a specific competency and a step in the work process. The symbol (O) indicates a correlation between a general and a specific competency. Shaded symbols indicate that these relationships have been taken into account in the formulation of objectives intended to develop specific competencies related to the trade.

The logic used in constructing the grid influences the course sequence. Generally speaking, this sequence follows a logical progression in terms of the complexity of the learning involved and the development of the students' autonomy. The vertical axis presents the specific competencies in the order in which they should be taught. The modules including the general competencies on the horizontal axis should be taught in relation to those on the vertical axis. This means that some modules are prerequisite to others, while other modules are taught concurrently.

4 GENERAL OBJECTIVES

The general objectives of the *Hairdressing* program are presented below, along with the major statement of each corresponding operational objective.

To develop in the students the basic competencies required to perform hairdressing activities

- Prevent health and safety incidents.
- Examine the scalp and hair.
- Analyze a client's morphology and physiognomy.
- Communicate with clients.

To develop in the students the competencies required to provide general hairdressing services

- Shampoo hair.
- Give a hair and scalp treatment.
- Set hair.
- Style hair.
- Give a standard haircut to a female client.
- Give a gradual haircut to a male client and trim his beard.
- Give a standard permanent.
- Colour hair.
- Colour hair in pastel shades.
- Do a colour correction.

To develop in the students the competencies required to provide specific hairdressing services

- Give a styled haircut.
- Give a styled permanent.
- Do a creative colouring.
- Give a personalized hairstyle.
- Sell products and services.

To develop in the students the competencies required to enter the work force

- Determine their suitability for the trade and the training process.
- Take part in the working world.

5 OPERATIONAL OBJECTIVES

5.1 DEFINITION

An operational objective is defined for each competency to be developed. Competencies are organized into an integrated training program designed to prepare students to practise the trade or occupation. This systematic organization of competencies produces better overall results than training by isolated objectives. More specifically, it fosters a smooth progression from one objective to the next, saves teaching time by eliminating needless repetition, and integrates and reinforces learning material.

Operational objectives are the main, compulsory teaching/learning targets and they are specifically evaluated for certification. There are two kinds of operational objectives: behavioural and situational.

- A **behavioural objective** is a relatively closed objective that describes the actions and results expected of the student by the end of a learning step. Evaluation is based on expected results.
- A **situational objective** is a relatively open-ended objective that outlines the major phases of a learning situation. It allows for output and results to vary from one student to another. Evaluation is based on the student's participation in the activities of the learning context.

First-level operational objectives cover the learning that the students need to develop a competency:

- The specifications or the phases of the objective determine or guide specific learning, thereby allowing the competency to be developed step by step.
- The objective as a whole (i.e. the six components and in particular the last phase of a situational objective) determines or guides the overall learning and the integration and synthesis of this learning, allowing the competency to be developed fully.

5.2 HOW TO READ AN OPERATIONAL OBJECTIVE

5.2.1 How to Read a Behavioural Objective

Behavioural objectives consist of six components. The first three provide an overview of the objective:

- The **expected behaviour** states a competency in terms of the general behaviour that the students are expected to have acquired by the end of the module.
- The **conditions for performance evaluation** define what is necessary or permissible to the students during evaluation designed to verify whether or not they have attained the objective. This means that the conditions for evaluation are the same wherever and whenever the program is taught.
- The **general performance criteria** define the requirements by which to judge whether or not the results obtained are generally satisfactory.

The last three components ensure that the objective is understood clearly and unequivocally:

- The **specifications of the expected behaviour** describe the essential elements of the competency in terms of specific behaviours.
- The **specific performance criteria** define the requirements for each of the specifications of behaviour. They ensure a more enlightened decision on the attainment of the objective.
- The **field of application** defines the limits of the objective, where necessary. It indicates cases where the objective applies to more than one task, occupation or field.

5.2.2 How to Read a Situational Objective

Situational objectives consist of six components.

- The **expected outcome** states a competency as an aim to be pursued throughout the course.
- The **specifications** outline the essential aspects of the competency and ensure a better understanding of the expected outcome.
- The **learning context** provides an outline of the learning situation designed to help the students develop the required competency. It is normally divided into three phases of learning:
 - information
 - performance, practice or involvement
 - synthesis, integration and self-evaluation
- The **instructional guidelines** suggest ways and means of teaching the course to ensure that learning takes place and that it takes place under the same conditions everywhere. These guidelines may include general principles or specific procedures.
- The **participation criteria** describe the requirements the students must fulfil. They focus on how the students take part in the activities rather than on the results obtained. Participation criteria are normally provided for each phase of the learning context.
- The **field of application** defines the limits of the objective, *where necessary*. It indicates cases where the objective applies to more than one task, occupation or field.

- Entertaining the possibility of starting a business or working for themselves.
- Comparing their knowledge of the trade with the actual situation.

PHASE 2: Information on and Participation in the Training Process

- Gathering information on the training process.
- Defining their career objectives with regard to the job market.
- Taking inventory of the competencies they must develop to attain their career objectives.

SITUATIONAL OBJECTIVE

PHASE 3: Evaluation and Confirmation of Career Choice

- Observing the organization and operation of the workplace during a one-day visit.
- Assessing their career choice by comparing the requirements of the trade with their own preferences, aptitudes and interests.

INSTRUCTIONAL GUIDELINES

- Provide the students with assistance in their research.
- Have experts in the field meet with students.
- Provide students with a realistic view of the trade and the training program.
- Encourage students to question their career choice and clarify their expectations with regard to the trade.
- Emphasize the need for students to have clear career objectives.
- Encourage students to make connections between the training process and their career objectives.

PARTICIPATION CRITERIA

PHASE 1:

- Gather and consider the information required.
- Present their impressions of how being a hairdresser will affect their personal and social lives.
- Adopt a realistic view of entrepreneurial possibilities in hairdressing.

PHASE 2:

- Name some competencies that this program aims to develop.
- Define a few career objectives they hope to attain in the short and medium term.
- Identify the competencies they need to acquire to attain their career objectives.
- Establish a connection between their career objectives and the competencies required in the program of study.

PHASE 3:

- Observe the organization and operation of the workplace during a one-day visit.
- Write a report in which they:
 - briefly compare the requirements of the trade with their preferences, aptitudes and interests
 - clearly explain whether or not they made the right career choice

SITUATIONAL OBJECTIVE

EXPECTED OUTCOME

By participating in the required activities of the learning context according to the indicated criteria, the students will **take part in the working world**.

SPECIFICATIONS

- Look for a practicum position.
- Practise the trade of hairdresser in a real work context.
- Pursue their personal and vocational development in the working world.

LEARNING CONTEXT

PHASE 1: Looking for a Practicum Position

- Identifying establishments likely to accept student trainees.
- Choosing an establishment and requesting an interview.
- Preparing and presenting a résumé.
- Making an application and requesting an answer.

PHASE 2: Practising the Trade

- Becoming familiar with the organization and operation of the establishment.
- Observing and participating in all the tasks performed by the hairdresser.
- Asking for feedback from the supervisor.
- Keeping a daily log.

SITUATIONAL OBJECTIVE

PHASE 3: Evaluation

- Presenting a report on the practicum.
- Discussing their experience with the instructor.
- Participating in the evaluation of the practicum.

INSTRUCTIONAL GUIDELINES

- Provide students with preliminary information and the terms and conditions of the practicum.
- Make preliminary contact with establishments in the region and make a list of possible practicum positions.
- Set up formal arrangements for support and supervision of trainees.
- Make arrangements for cooperation between the establishments and the school.
- Provide the students with support in their search for practicum positions.
- Visit the student trainees at their workplaces.
- Resolve any problems that arise during the practicum.
- Evaluate the establishments and the quality of the supervision they provide.
- Meet with students at the school on an individual basis halfway through the practicum to discuss their experience, using their daily logs.
- Encourage the students to evaluate their practicum critically.

PARTICIPATION CRITERIA

PHASE 1:

- Prepare for an interview and write a résumé in accordance with the established rules.
- Carry out all the steps in the search for a practicum position.
- Explain their choice and present the results of their search to the instructor.

PHASE 2:

- Agree to take part in all the activities proposed.
- Participate actively and constructively in meetings with the practicum supervisor.
- Keep a daily log.
- Adopt appropriate attitudes and behaviour throughout the practicum.

PHASE 3:

- Write and present a report on the practicum in accordance with the instructions given.
- Present various aspects of their experience during the practicum.
- Participate actively in the evaluation of their practicum.
